In the Manner of the Privacy Statement for Participants in Educational Events and Conferences

Road Contractors Association, with its registered office at Thámova 181/20, Karlín, 186 00 Praha 8, ID 60460491, registered in the Register of the Associations kept at the Municipal Court in Prague, Section L, File 52405 (hereinafter "Controller"), processes the participants' data of educational events and conferences in the scope of the name, surname, name of the entity for which the event participates, designation of a training event or conference (date and title), in order to ensure the participation of these persons at a training event or conference and to fulfill the tax obligations.

Provided that the data subject grants the consent, the Contoller is authorized to process his or her personal data within the private email address of a natural person for the purpose of offering training events or conferences organized by the Controller. This consent can be withdrawn at any time, for example by sending an email or a letter to the Controller, for the attention to the executive director. The withdrawal of the consent is without prejudice to the lawfulness of the processing of personal data in the period prior to the withdrawal of the consent. Business emails containing the domain name of the legal entity for which the natural person works (typically in the form of the name.surname@employer.cz) are obtained by the Controller from the affected employer. The Contoller processes them regardless of the consent of the natural person.

The data are processed for 10 years.

Personal data processing does not involve the automated decision making or profiling.

The processing of personal data is carried out by the Contoller, but the personal data may also be processed for the Controller by the Authorized member of the Road Contractors Association the PRAGOPROJEKT, a.s., with its registered office at Prague 4, K Ryšánce 1668/16, postal code 14754 and possibly other persons.

The data subject has **the right** at any time to ask the Controller to **confirm** whether the personal data concerning him / her are processed or not and, if so, has the right to have the access to these personal data and processing information supposing he / she provides the sufficient information enabling the data subject to be identified.

The Controller shall provide the data subject at his / her request with a copy of the processed personal data.

The data subject has **the right to correct personal data** if they are inaccurate or incomplete. The Controller is required to comply with the request within one month from receiving the application.

The data subject has the right to the deletion of personal data if one of the reasons set out in European Parliament and Council Regulation (EU) 2016/679 (the General Data Protection Regulation) is given.

The data subject **has the right to request the limitation** on the processing of personal data under the conditions laid down in the General Data Protection Regulation.

The data subject **has the right to be provided** by the Controller with the information on the measures taken, without the undue delay and no later than one month after the application has been submitted. If the controller fails to take the asked action, the controller shall inform the data subject of the reasons for non-acceptance and the possibility of lodging a complaint with the Supervisory Authority - the Personal Data Protection Office, if the data subject considers that the processing of his or her personal data violates the GDPR Regulation.
